Dear Friends,

My greatest gift of this past year has been the rediscovery of my power to dream. As a child, dreaming was as much a part of my existence as breathing. I dreamed of warm summers that lasted forever, winter months filled with soft snow, warm fires and peppermint candy, and close encounters with Santa Claus, the Easter Bunny, the Tooth Fairy and my Fairy God Mother. As I grew those childhood myths gave way to warnings to grow up and face reality, to accept the "fact" that my life was beyond my control. But the years have restored my faith in the power of dreaming: dreams can lead us to untold possibilities.

Consider this year in the life of the Chinook Fund. A couple of years ago we started dreaming boldly, and we envisioned taking a more active role in social justice advocacy in Colorado. We created an ambitious strategic plan, and expanded our mission statement to reflect our purpose of transforming Colorado through the elimination of all oppression: racism, sexism, classism, heterosexism, and other forms of oppression. As in my personal life, the Chinook Fund's dreams are now bearing fruit. It seems that as soon as we dream of a new possibility, it appears - before we can finish the sentence! We have grown in programs and program participants, in staff, in volunteers, and in our spirit.

PROGRAMS

Through **Chinook's grants and technical assistance**, we are cultivating inspiring grantees from across Colorado, from Boulder to the San Luis Valley to Grand Junction and points in between. These grantees are bringing the hope of social justice to their communities, advocating on a range of issues including higher wages and employment benefits for low-wage earners; legal equality for LGBTQ persons; fair treatment for immigrant workers; housing and dignity for persons living with physical and mental disabilities; respect and safe havens for young people living with heart-breaking challenges; and empowerment and safety for domestic violence victims. The work of these organizations is grounded in the dream of justice for all people, and powered by their deep commitment to social change.

Chinook's Social Justice Institute (SJI), now in its third year, is a nine-week program offered twice annually for promising activists from Denver's four Making Connections neighborhoods. Over seventy-five participants have learned effective community organizing strategies and how to identify and transcend the racism, sexism, classism and other oppressions that divide even the most progressive people and movements. Inspiring SJI graduates like Veronica Quezada (from the North Lincoln Park neighborhood) and Jamesetta Smith (Cole neighborhood) are now sharing their knowledge with their communities and as members of the Chinook Fund's grant-making committee.

Chinook's Social Justice Awareness (SJA) is our newest education program. Chinook staff and volunteers professionally assist non-profit and governmental organizations in identifying institutional oppression in their workplaces and transforming their organizations into authentically inclusive environments. Incredibly, although our SJA program was not scheduled to be launched until this fall, we have already conducted six training seminars for over 130 people. We have several more seminars in the planning stages, thanks to the importance of and need for this work.

STAFF

This year we have honored two treasured employees and a priceless volunteer as they have made changes in their lives: **DeQuan Mack, Nick Sarchet and Yvette Freeman**. But while they have moved on to pursue new dreams, we are blessed that all three remain connected with Chinook, in new roles. This year we also welcomed three new staff members into our community, and recognized the growth of a long-time employee:

Eva Benavidez-Clayton is Chinook's new program officer. With an extensive professional background in anti-violence advocacy, Eva leads the Social Justice Institute program, sharing her wealth of anti-oppression and community organizing knowledge and experience with the community activists who enroll in Chinook's ground-breaking SJI program. Eva also provides invaluable staff assistance to Chinook's all-volunteer grant-making committee.

Jenny McDonald is Chinook's new development officer. Jenny has taken the reins of Chinook's development efforts, and is helping to redesign our development infrastructure. With Jenny's contagious enthusiasm for the work and people of Chinook, we have experienced a productive development year, and we are anticipating a stronger 2006, as we further expand and diversify our donor community.

Dani Newsum is our new communications and education officer. Dani is an accomplished trainer in our new Social Justice Awareness program. She plays a lead role in Chinook's written communications, and is significantly involved in our development initiatives. Dani, a former civil rights attorney, is also a political commentator on Denver TV, teaches in the history and political science departments at the University of Colorado-Denver and writes for the DenverPost.com.

Erica Vigil joined the Chinook Fund five years ago as our office manager. This year, Chinook acknowledged Erica's contributions to our work, as well as her professional growth, and her leadership within our community by naming Erica associate director of the Chinook Fund.

In spite of the warnings of my youth, I always kept a dream or two stowed away; and the years since have shown me the positive power of dreaming. The personal growth and transformation that I've experienced were once "just" dreams of new possibilities. As president of the Chinook Fund board of directors, it has been amazing for me to see our dreams becoming reality through the dedication and hard work of the incredible people who make up our Chinook community of grantees, volunteers, staff, graduates and donors.

I am excited to see what the coming years and dreams bring. Be careful what you ask for; you just might get it!


